

## Required Documents for Visa of

European union citizens' relatives (Includes **Spouse**, Children, Parents, Father-in-law and Mother-in-law)

### Mandatory Documents:

1. Visa Application Form
  2. Recent passport size photograph
  3. Passport or travel document valid for at least three months after visa expiry date
  4. Copy of the EU or European Union citizen's identity document or passport along with a declaration requesting the presence of the family member in Italy and swearing to be in possession of the requisite foreseen by the law.
  5. Income Tax form from Italy
  6. Requisiti di abitabilità dell'alloggio (Technical notice) certificate from Italy
  7. Carta D'identità of Italian citizen
  8. Photocopy of Passports
9. Ticket booking copy (Booking date should be at least 30 days later from the date of submission)

### Additional Administrative Documents:

#### **When applying for wife/husband:**

- A) Marriage should be registered in Italy (from Italy or from Consular section)
- B) Marriage certificate, Bangla and English Nikahnama Notary public, Attested from Ministry of Foreign Affairs Dhaka) or if the marriage is registered in Consular section (Italian Embassy, Dhaka), photocopies of legalized marriage documents along with the marriage registration certificate should be submitted
- C) Family certificate (Notary public, Attested from Ministry of Foreign Affairs Dhaka)
- D) Family photograph, marriage photograph

#### **When applying for children:**

- A) Birth Certificate of children (Notary public, Attested from Ministry of Foreign Affairs Dhaka).
- B) Marriage registration document of applicant's parents (marriage should be registered in Italy (from Italy or from consular section, Dhaka).
- C) Marriage Certificate, Bangla and English Nikahnama Notary public, attested from Ministry of Foreign Affairs Dhaka or if the marriage registered in Consular section, Dhaka, photocopies of legalized marriage documents along with the marriage registration certificate should be submitted.
- D) Family Certificate.

#### **When Applying for Parents:**

- A) Birth certificate of Italian Citizen (Notary public, Attested from Ministry of Foreign Affairs Dhaka)
- B) Marriage Documents of the applicant that are Marriage certificate, Bangla and English Nikahnama (Notary public, Attested from Ministry of Foreign Affairs Dhaka)
- C) Family Photograph.
- D) Family Certificate

#### **When Applying for Father-in-law and Mother-in-law:**

- A) Marriage certificate of Italian citizen
- B) Marriage Documents of the applicant that are Marriage certificate, Bangla and English Nikahama (Notary public, attested from Ministry of Foreign Affairs Dhaka)
- C) Birth certificate of Applicant's son/daughter (Spouse of Italian citizen)
- D) Family certificate of the applicants and sponsor (Notary public, Attested from Ministry of Foreign Affairs Dhaka)
- E) Family photograph
